REGULATION

On the Procedure for Reimbursing the Tuition Fees of Female Students Admitted to and Studying in Master's Programs of State Higher Education Institutions on a Contract Basis from the State Budget of the Republic of Uzbekistan

of Tashkent State university of Uzbek Language and Literature

Chapter 1. General Provisions

1. This Regulation establishes the procedure for reimbursing, from the State Budget of the Republic of Uzbekistan, the full tuition fee for one academic year for female students who have been admitted to and are studying in master's programs at state higher education institutions on a contract (tuition-paying) basis, starting from the 2022/2023 academic year.
2. This Regulation applies to female students enrolled in master's programs on a contract basis at state higher education institutions, including the **Academy of Public Administration under the President of the Republic of Uzbekistan**, the **Academy of the General Prosecutor's Office**, the **Higher School of Business and Entrepreneurship under the Ministry of Economic Development and Poverty Reduction**, and the **Banking and Finance Academy** (hereinafter referred to as *applicants*).
3. The full tuition fee (excluding differentiated tuition payments) for the academic year shall be reimbursed to the relevant higher education institutions from the funds allocated from the State Budget of the Republic of Uzbekistan on a **non-repayable basis**.
4. The funds allocated from the State Budget for applicants shall be reflected in the **personal treasury accounts** of the Ministry of Higher and Secondary Specialized Education under expenditure classification code **48 21 190 – "Other Expenses"**, planned quarterly and monthly.
Starting from 2023, these funds shall be allocated from the **Republican Budget** to the respective ministries and agencies according to the institutional subordination of each higher education institution.

Chapter 2. Identification and Compilation of Applicants' Lists

5. Starting from the 2022/2023 academic year, applicants wishing to have their tuition fees reimbursed from the State Budget shall submit an application addressed to the **rector (or branch director)** of their respective higher education institution by **September 15** of the current academic year. Applications submitted after this deadline shall not be considered.

6. The submitted applications shall be reviewed and summarized by the higher education institution within **three working days**.
7. In 2022, the consolidated list of applicants shall be submitted within **five working days** to the Ministry of Higher Education Science and Innovation for reimbursement.
Starting from 2023, the lists shall be sent within **five working days** to the relevant ministries or agencies according to the institutional subordination of the higher education institution.

Chapter 3. Reimbursement of Tuition Fees to Applicants from the State Budget

8. The reimbursement of tuition fees for female students admitted to and studying in master's programs on a contract basis shall be carried out in accordance with the **scheme provided in the Annex** to this Regulation.
9. Based on the submitted list of applicants, the **Ministry of Higher Education Science and Innovation** shall, within **three working days**, submit a request to the **Ministry of Finance** to transfer the required funds to the personal treasury accounts of the higher education institutions.
The Ministry of Finance shall ensure the transfer of funds to the respective accounts **by May 20** each year in accordance with the established procedure.
Starting from 2023, these funds shall be reflected in the institutions' budget expenditure plans.
10. Beginning with the 2022/2023 academic year, a **rector's (or branch director's) order** confirming reimbursement of the full tuition fee from the State Budget shall be issued **no later than October 15** of the current academic year.
11. The allocated budget funds for applicants shall be reflected under the same expenditure classification code **48 21 190 – "Other Expenses"**, planned quarterly and monthly.
12. The reimbursed funds shall be transferred to the **off-budget (contract-based)** personal treasury accounts of the higher education institutions and shall be spent in accordance with established procedures.
13. In cases where the allocated budget funds are insufficient to fully reimburse tuition fees, higher education institutions shall submit requests for **additional budget allocations** to the relevant ministries and agencies according to their institutional subordination.
14. The reimbursement from the State Budget shall be made **in an amount equivalent to the base (non-scholarship) tuition fee** established for each field of study.

Chapter 4. Final Provisions

15. The **rector (or branch director)** of each higher education institution shall be personally responsible for ensuring the proper and timely reimbursement of the full tuition fee from the State Budget for the academic year, starting from 2022/2023.

16. Information on the funds allocated from the State Budget for reimbursement shall be published on the **official website of the higher education institution**. These data shall be **updated quarterly** and presented in a **yearly breakdown**.
17. Oversight of the **targeted and efficient use** of the funds allocated from the State Budget shall be carried out by the **State Financial Control Inspectorate**.

18. Individuals responsible for violations of the provisions of this Regulation shall be held **liable in accordance with applicable legislation**.
